Minutes of Meeting of Grievance Redressal Committee held on 05.09.2016

The Principal introduced the members of the committee to the parent of the student's for whom show cause notice was issued on 31.08.2016.

Principal narrated to each parent the involvement of their ward on the incident that has happened in the college on 23.08.2016.

Statement 1: Mr.Rahul P, S7-ME,

Mr. Sathish was present instead of parent. He said he was elder brother of Rahul P. Mr.Sathish requested principal to help Rahul P to continue the course. He understood that Rahul P has involved in the incident.

Statement 2: Mr. Kanz M, S7-ME,

Dr. Liyakath Ali M, General Physician, MIMS, Calicut was present instead of parent. He said he was Uncle of Kanz. He understood that Kanz M has involved in the incident. Dr. Liyakath Ali M, requested principal to help Kanz M to continue the course, He promised that Kanz M will not involve in any such incident in future.

Statement 3: Mr.Bijoy Biju, S7-ME,

His father was present. Bijoy Biju stated that he was not involved in any incident that has happened on 23.08.2016. But he told that his Spectacles was broken in the fight. Mr. Shine, S5 -ME, contacted him and told that he was trapped by S5 students.

Statement 4: Ajin Sabu Daniel S7-CE

His Father was present. Ajin Sabu Daniel denied all the allegation against him. He said he asked Subin J Varghese, S5-EEE to move away from the place.

Statement 5: Sreekrishnan S7-ME

His Father was present on 06.09.2016. Sreekrishnan said since he is the roommate of Rahul P and Kanz M, He was with them in all the places. His Father understood his involvement, He promised that his son will not involve in any such incident in future.

Grievance Redressal Committees suggestion after the hearing and reading the explanation given by the students and parent on 05.09.2016 for the show cause notice issued on 31.08.2016.

1. Mr. Rahul P, S7-ME and Mr. Kanz M, S7-ME, were not able to prove their innocence and involvement in the incident that happened on 23.08.2016. It is clearly proven by the evidence provided by the enquiry committee that both Mr. Rahul P and Mr. Kanz M were the main origin for the incident that happened on 23.08.2016 and they have involved in manhandling in all the 3 places where the incident took place. Further Mr. Kanz M, S7-ME, being the student chairman of the college, should have taken necessary step to avoid any trouble to the student members of the institution, but he himself has provoked and involved in such activities, hence we suggest the Principal to take away all his authority as student chairman. It is also suggested to receive a TC requisition letter from both Mr. Rahul P, and Mr. Kanz M, which may be used, if in any future incidents if their presence, involvement or provoking is found. Considering their academic performance disciplinary action may be taken.
2. Mr. Bijoy Biju, S7-ME, Mr. Sreekrishnan S, S7-ME and Ajin Sabu Daniel, S7-CE were not able to prove their innocence and involvement in the incident that happened on 23.08.2016, it is clearly proven by the enquiry committee that they have involved in manhandling. It is suggested to receive a TC requisition letter from Mr. Bijoy Biju, S7-ME, Mr. Sreekrishnan S, S7-ME and Ajin Sabu Daniel, S7-CE which may be used, if in any future incidents if their presence, involvement or provoking is found.
3. As per the suspension order MBC/ADN/GEN/2016/26 dated 25.08.2016 and the Memo order MBC/ADN/DIS/16 dated 02.09.2016, Attendance may be given on 01.09.2016 for the students whose suspension where revoked with effect from 01.09.2016. Since the suspended student's presence was available on the spot of incident, Attendance may not be given from 29.08.2016 to 31.08.2106.
4. Attendance may be given on 03.09.2016 for the students, if they were present for the class on that day.

5. Attendance may be given to Arjun S Alelil, S5-ME from 29.08.2016 to 01.09.2016, since no evidence is available for his presence in the incident that took place on 23.08.2016.
6. Attendance may be given to Ligin George, S7-ME, Dilin Philip, S7-CSE, Eapen V Palooran, S7-EEE, Jerin K George, S7-ME, Amal Ashok, S5-CE, Alex Thomas, S5-EEE, Jinto Jacob, S5-ME from 29.08.2016 to 01.09.2016, These students have not requested the grievance redressal committee for attendance. But based on the evidence of the enquiry committee report their presence or involvement in the incident that took place on 23.08.2016 is negligible.
