Minutes Of Meeting Of Grievance Redressal Committee Held On 19.09.2018

Principal introduced himself and members of the committee before the parents present for the meeting. Principal briefed the incident, college rules and seriousness of ragging. As per report of enquiry, parents of 8 students including victim (Alan Joseph S3 CE), were called for the grievance redressal before the committee. Committee have interacted with the parents along with the students.

Alan Joseph in the presence of his parent admitted that the incident had happened and he was a victim and his complaint is true. His parents are not interested to continue with the complaint further. They informed that they had a compromise talk with the parents of students who are involved in the incident.

All students, Abraham Mathew (S7 EEE), Regin Tom (S7 EEE), Rahul Raj (S7 EEE), Bijo Varghese (S7 ME), Danesh M Nair (S7 ME), Steevo Tom Jacob (S7 ME), Rahul Raj (S7 ME), have accepted that they were directly or indirectly involved in the incident which happened in mess hall and corridor of college hostel (MH-2).

The committee observed that all students have regrets regarding the incidents. They ensured that there will not be any incidents in connection with it inside college or hostel in mere future. They also admitted that they didn't purposefully misbehave with the victim.

All students mentioned above reported along with their Parent/ Guardian for the grievance redressal committee meeting. The committee interacted with each student along with their parents.




Following were the observations by the committee.

1. Students admitted that they didn't purposefully misbehave with the victims, it all happened in that instance.
2. Allen Joseph (S8CE) was also a victim of physical alteration by S6 Students which led him to lose his control next day
3. Students also admitted in their written statement, they won't involve in any incidents in connection with it, inside college or hostel in mere future.
4. All student have regrets on the incidents happened.

Recommendations


1. Committee recommend to reduce, punished given to Allen Joseph to 7 days
2. Considering the smooth functioning of programmes proposed by college in future and ensure peace between 3rd and 4th year students. Committee suggests to reduce the punishment of all student who involved in incident by 2 days (7 consecutive day's suspension)
