TERMS & CONDITIONS

As per the discussions we had upon signing this Memorandum Of Understanding (MOU) between both the parties - the following conditions are to be satisfied by both parties for its successful implementation.

- First party will include second party's logo and description of second party in firstparty's website.
- First party will incorporate second party in National and International programs.
- First party will conduct Faculty Development Programs, Placement drives in association with second party.
- MOU signing ceremony will be conducted in a large scale event in the presence of Minister level political personality. (if MOU signed with College)
- On signing this Memorandum of Understanding (MOU) the second party agrees to provide the first party with necessary space to setup its classrooms and facilities. Seminar rooms with Projector facility shall be allotted upon request. The space allocated should be easily accessible to students.
- First party will install and maintain the training software's for training purpose.
- Will conduct a FDP in respective department for free of cost.
- The second party shall strictly not entertain any type of MOU between similar institutions during one tenure.
